92nd Annual BWM State Conference To Convene April 26 At The Lodge of the Four Seasons, Lake Ozark, MO

The Ninety-Second Missouri Business Women State Conference is coming soon. We have a full weekend planned for you! Plus get a little bit of relaxation. The Lodge of The Four Seasons will welcome us with open arms.

The full registration package is only \$5 more than last year and Saturday lunch is included. We will kick off the conference weekend on Thursday evening when early arrivals are invited to join the state board for dinner and s'mores by the fire.

The State board meeting and lunch begins at 9:30 a.m. on Friday. All members are welcome to attend. This is an optional meeting and lunch, so please check the appropriate boxes on the registration form and include payment for your lunch. The Missouri Foundation Silent Auction will be accepting bids starting at 2:00 p.m. So be sure that your items are turned in to Foundation members.

The 92nd Annual State Conference will begin Friday with Registration at 5:00 p.m. followed by the first General Session at 7:00 p.m. Following the meeting, you are all invited to join President Megan's reception located in the Executive Suite.

Saturday events begin with homemade goodies and coffee for sale by the Foundation. The First Timer's Workshop, "Explore BWM" and Regional Directors training will begin at 7:30 a.m. The General Session begins at 8:30 a.m. and will include lunch for all registered attendees. During lunch, we will have a "Paddle Party" so bring your quarters.

Following lunch, two workshops will be available with times being staggered so all attendees will be able to attend both. The workshops are

Individual Growth Update

Three Rivers BWM hosted the Individual Growth program in Owensville. Eleven ladies graduated and are eligible to compete at the State Conference in April.

Ellen Hill, PSP, St. Louis Metro BWM, joined me in presenting all 15 modules, and while the program is a lot of information to absorb in one day, everyone had a good time and learned new ways to communicate with and work with differing personalities. The DISC Model of Human Behavior is used throughout the program to teach ways to communicate as an employer, as a co-worker, and as a friend or family member. Hope Mundwiller accommodated us at her Fireflie

Photography studio and the ladies from Three Rivers BWM provided a wonderful lunch. Feedback from the participants was positive and everyone enjoyed the day.

Peggy Cochran held IG training on modules 8-15 on Jan. 26th in Osage Beach. With her sister Deborah Brasfield, assisting her with the training, they had 18 participants. Ms. Brasfield is a nationally-certified BPW trainer and the ID Chair from Tennessee. They plan to offer modules 1-7 next year during the same time frame.

Carole Parson and the St. Joseph BWM hosted a Business Women Career Training program and used the modules from the IG program to educate young ladies in three sessions that were held January 19, February 15 and March 15. At the time of this report, the number of attendees was not available. I met

with the Executive Committee and with the Individual Growth and Generations Taking Charge Chairwomen for next year and we started the process to implement changes to the

programs. The goal is to mold the program to meet the needs of today's young business woman, along with providing the information we have found valuable in the past.

Legislative Conference Report

Due to the statewide storm on February 20, and deliberation most of the day on February 21, we decided to postpone the Legislative Conference. The Hotel had the weekend of March 15-16 available and were willing to transfer our meeting and rooms with no charges, so we accepted their offer. All of our speakers assured us that we had made a good call in postponing the Conference. Most of the speakers were able to transition with us to the new weekend, but one was not, so we are in the process of replacing her.

Jo sent out an eblast to all stating that if you were registered and were still planning to come in March, your room reservation would be transferred to the new date with no action on your own.

During my 28 years in this organization, I am unaware of this Conference having to be postponed. I am walking around the boxes and bags of "stuff" for the Conference that are still in my dining room waiting to be loaded in my car.


I may have to call for some assistance, too, because my co-chair, Angie Moran, PSP, does not think she can attend in March because that is a crucial corporate tax landmark in the tax world. She has completed the paperwork that we needed for the Conference. Angie, you will be missed if you do not get to attend. I'm still hoping that you can swing it.

See you all at Legislative Conference on March 15-16. And thank you for your patience.

Approved Bylaws 12-01-12

The Executive Committee recommends that the bylaws be amended as follows:

Article XVII: State Conference

Section 1 be replaced with the following:
The annual conference of BWM shall be held in the spring of each year at such time and place presented at the December Board meeting approximately 18 months prior to the conference date but not later than the Spring Board meeting prior to State Conference one year to the conference date.

Rationale: Many hotels and convention centers will not guarantee date and pricing for conferences our size any earlier than the above time-frame.

The Executive Committee recommends that the Bylaws be amended as follows:

Article II: Replace title "Mission" with "Mission, Vision and Objectives"

Insert the following as the Mission Statement:

The mission is to empower women personally, politically and professionally and to achieve equity for women in the workplace through advocacy, education and information.

Insert the following as the Vision Statement:

The vision is achieving equity personally, politically and professionally.

Insert the title "Objectives" for remaining phrases.

Rationale: Update bylaws to mirror the manual and the use of more contemporary language.

Both recommendations were approved. Coming from committee, no motion was needed

The ABCs of Membership

Assess the needs of your members, what they expect from BWM and their special interests and abilities.

Broadcast the accomplishments of your local club and set new goals.

Communicate women's issues to the community by providing well-planned programs and activities.

Demonstrate the need for women to be heard locally, statewide and nationally.

Encourage members to work together on important issues.

Foundation and scholarships are an important part of BWM.

Generate enthusiasm. It's contagious; soon others around you will be enthusiastic too.

Help is at hand from your BWM local, Regional, State, PSPs and more.

Involve new and current members in activities.

Joining a local BWM club also makes you a member of your Region and the state.

Kick off your yearly membership campaign by publicizing it in all local media.

Legislative issues of interest to women deserve our united support.

Membership is open to everyone throughout the year.

New ideas born from brainstorming keep programs and members out of a rut.

Opportunities for leadership, involvement and more abound at every BWM meeting and conference.

Programs that are meaningful keep members interested and involved.

Question your members about their concerns and where they feel BWM should be concentrating its efforts in the community.

Important Legislation for VAWA (Violence Against Women ACT)

VAWA Reauthorization passed the U.S. House on February 28, 2013, and at press time, President Obama had signed the bill into law.

The bipartisan Senate bill, S. 47, to reauthorize the federal Violence Against Women Act (VAWA) was passed by the U.S. House of Representatives on a vote of 286 in favor and 138 against. The votes in favor included 87 Republicans and 199 Democrats. All votes in opposition were cast by Republicans.

The House held an earlier vote to adopt a substitute VAWA reauthorization bill sponsored by House Republicans — it was defeated by a vote of 257 against and 166 in favor.

This was an amazing victory of determined advocacy by advocates throughout the nation.
